

## **ESPN Email Sweepstakes: Adam Sandler**

ESPN Des Moines is offering an exclusive sweepstakes to its email club members. Club members will have the opportunity to enter to win a pair of tickets to see Adam Sandler at Casey's Center on Thursday, October 23rd.

During the week of June 23rd, an email blast will go out to the email club members with a link to the contest page. To enter, members of the email club may click the link to the contest page within the email and complete the registration form. The contest will close at 11:59 PM on Sunday, June 29th. Those who are not yet in the Email Club may join before 9:00 am on Monday, June 23rd for the chance to enter the contest. One winner will be selected at random from the collected entries and contacted the following week of the contest.

Listeners may only enter once. Any attempt to enter more than once will disqualify the entrant, including by using someone else's personal information. The use of software or hardware that gives its user an advantage over other contestants by automating their entries into any contest is prohibited and will disqualify said user. If there is a dispute over an entry, the authorized account holder of the email address used to enter will be considered the entrant and must be eligible to win under these official rules. Only one win is permitted per household. 102.1 ESPN radio has the final say as to who wins their contests.

By entering this contest, listeners understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, 102.1 ESPN radio may share that Personal Data with sponsors, advertisers, affiliates, or other partners. These tickets are DIGITAL and winners must have a valid email address to receive and use them. The tickets will be delivered upon the completion of an electronic waiver sent to the

email address collected at the time of entry or as soon as Des Moines Media Group has received access to the tickets. KRNT/102.1 ESPN will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station's control. Winners are expected to follow all COVID-19 guidelines, plus any other rules and restrictions put forth by the event organizers and concert venue.

No purchase necessary. This prize has an approximate retail value of \$200. Prizes are non-transferable and cannot be exchanged or substituted for cash. Winners must present a valid state ID and w9 to collect the prize. Winners are responsible for all local, state, and federal taxes and fees associated with the prizes. - No purchase is necessary to enter any 102.1 ESPN contest.
- To be eligible to win any prize on 102.1 ESPN you must not have won anything on 102.1 ESPN or any other Des Moines Media Group radio station in the past 30 days or any prize valued at \$600 or more in the past 6 months. Only one winner per household is permitted within 30 days after a household has a winner. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.
- Anytime you call the 102.1 ESPN studios you assume that your call will be broadcast or recorded and you grant us permission to broadcast the call or record it for later broadcast.

require a specific caller to telephone the radio station (such as “Caller number 9 when you hear the sound effect”), listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contests on-air.
