

ESPN Online Sweepstakes: Iowa State Fair Ticket Giveaway

102.1 ESPN Des Moines will be running an online contest that will start Monday, July 21st at 12:00 am and run through Sunday, August 3rd at 11:59 pm. Listeners will have the chance to win a pair of general admission tickets to the Iowa State Fair.

To enter, listeners must go to espndesmoines.com and enter under the corresponding contest title page. Listeners must fill out the contest form and submit before 11:59 pm on Sunday, August 3rd to be eligible to win. Five winners will be drawn at random from the collected entries and contacted the following week of the contest.

Listeners may only enter once, and multiple entries by an individual, including entries made by using someone else's personal information, will disqualify them. The use of any software or hardware that gives its user an advantage by automating their entries into any contest is prohibited and will disqualify said user. Only one winner is permitted per household. In the event of a dispute over an entry, the authorized account holder of the e-mail address used to register will be deemed to be the registrant and they must be eligible to win according to these official rules. 102.1 ESPN radio has the final say as to who wins their contests.

By entering this contest, listeners understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. We are open Monday through Friday from 8:00 am to 5:00 pm. 102.1 ESPN will not be held responsible if any events are cancelled, or prizes cannot be redeemed, due to circumstances outside of the station's control. Winners are expected to follow all COVID-19 protocols, or any other rules and restrictions put in place by the event organizers and venue. 102.1 ESPN will make every reasonable effort to award prizes before any expiration dates or showtimes.
