

ESPN Online Sweepstakes: NASCAR Xfinity/Arca Series

102.1 ESPN Des Moines will be running an online contest that will start Monday, July 7th at 12:00 am and run through Sunday, July 20th at 11:59 pm. Listeners will have the chance to win a pair of tickets to see either the ACRA Menards Series on Friday, August 1st or the NASCAR Xfinity Series on Saturday, August 2nd.

To enter, listeners must go to espndesmoines.com and enter under the corresponding contest title page. Listeners must fill out the contest form and submit before 11:59 pm on Sunday, July 20th to be eligible to win. Six winners will be drawn at random from the collected entries and contacted the following week of the contest.

Listeners may only enter once, and multiple entries by an individual, including entries made by using someone else's personal information, will disqualify them. The use of any software or hardware that gives its user an advantage by automating their entries into any contest is prohibited and will disqualify said user. Only one winner is permitted per household. In the event of a dispute over an entry, the authorized account holder of the e-mail address used to register will be deemed to be the registrant and they must be eligible to win according to these official rules. 102.1 ESPN radio has the final say as to who wins their contests.
