

ESPN Online Sweepstakes: Adam Sandler

102.1 ESPN Des Moines will be running an online contest that will start Monday, September 22nd at 12:00 am and run through Sunday, September 28th at 11:59 pm. Listeners will have the chance to win a pair of tickets to see Adam Sandler: You're My Best Friend Tour at Casey's Center on Saturday, October 4th.

To enter, listeners must go to espndesmoines.com and enter under the corresponding contest title page. Listeners must fill out the contest form and submit before 11:59 pm on Sunday, September 28th to be eligible to win. Five winners will be drawn at random from the collected entries and contacted the following week of the contest.

Listeners may only enter once, and multiple entries by an individual, including entries made by using someone else's personal information, will disqualify them. The use of any software or hardware that gives its user an advantage by automating their entries into any contest is prohibited and will disqualify said user. Only one winner is permitted per household. In the event of a dispute over an entry, the authorized account holder of the e-mail address used to register will be deemed to be the registrant and they must be eligible to win according to these official rules. 102.1 ESPN radio has the final say as to who wins their contests.

By entering this contest, listeners understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, 102.1 ESPN radio may share that Personal Data with sponsors, advertisers, affiliates, or other partners. These tickets are DIGITAL and will be transferred to winners via email, who will need a smartphone in order to use them at the arena. 102.1 ESPN Des Moines/KRNT will make every reasonable effort to transfer the tickets before the start of the event. 102.1 ESPN Des Moines/KRNT will not be held responsible if an event is cancelled due to circumstances outside of the station's control, and tickets, certificates, or other prizes cannot be redeemed. Winners are expected to follow all COVID-19 guidelines, plus any other rules and restrictions put forth by the event organizers and venue. The value of this prize is approximately \$150.

No purchase necessary. Prizes are non-transferable and cannot be exchanged or substituted for cash. Winners must present a valid state ID and w9 to collect the prize.

Winners are responsible for all local, state, and federal taxes and fees associated with the prizes. This KSTZ-HD2 contest is open to all eligible Iowa residents 18 or older who have not won anything on KSTZ-HD2, **nor any Des Moines Media Group station**, in the past 30 days.
